## **Narrative**

On 7/1/2015 at approximately 10:30 hours, I received a call for service at Hayward Field West Grandstand, 1560 E. 15th, Eugene, OR, 97403; a property owned and controlled by the University of Oregon. I was in full department issued uniform, badge prominently displayed, driving a marked patrol car.

Dispatch advised the complainant, Daniel T. Mackey, reported a physical harassment occurring at the U.S.A Outdoor Track and Field Championships at approximately 19:00-19:30 hours on 06/25/2015.

On 07/01/2015, at approximately 13:30 hours, I spoke with Mackey via a telephone call. He gave a brief description of an encounter with John Capriotti, that occurred in the athlete medical tent area of Hayward Field.

Mackey was undecided on if he wanted to report the incident officially, or pursue criminal charges. At that time, I offered to Mackey to complete an informational report taking note of the incident, or to complete a criminal report and pursue criminal charges. Mackey declined both, stating he needed time to determine the route he would like to take. I provided Mackey with my contact information and requested he call UOPD when he decided that he would like to report the incident officially, and what investigative route he would like me to take.

On 07/18/2015, at approximately 11:58 hours, I spoke with Mackey via a telephone call. Mackey stated he would like to speak with me in detail about the incident, have a report taken for the incident, but did not want to pursue any criminal charges. Mackey said, "I just want it recorded. I don't want you to pursue anything at this time."

Mackey provided several witnesses, as listed above, and stated he could work on getting some contact phone numbers, but did not have them at this time.

Mackey described the incident as occurring on 06/25/2015, at approximately 19:00-1930 hours. He stated he was sitting with Dorian Ulrey, who is an athlete that Mackey represents. The area they were sitting in was an athlete medical tent where athletes seek treatment, and testing after they finish an event, which was located on the turf fields directly west of Hayward Field. Mackey advised he escorted Ulrey to the tents once Ulrey finished an event.

Mackey stated, while he was sitting next to Ulrey, he felt Capriotti grab onto his right arm and pull him, almost picking Mackey up off of his chair. Mackey advised the following conversation went as such:

Capriotti: "We gotta talk right now."

Mackey: "I'm talking with Dorian. Gimme a minute."

Mackey stated Capriotti took a step towards Mackey and poked him in the chest with two fingers. Mackey described the poke as hard enough that, "It hurt. It pushed me back." Mackey stated Llewellyn Starks was standing approximately 6" in front of Mackey and was just staring at him.

Capriotti: "Well then we'll go outside mother fucker."

Mackey: "John. Relax. I'm gonna finish talking with Dorian."

Mackey said Capriotti knelt down with his nose touching Mackey's right ear.

Capriotti: "You know what you fuckin' did. I'm gonna fuckin' kill you."

Mackey stated he stood up, and when he did Starks stood there, chest to chest, continuing to stare at

Mackey.

Mackey: "I don't know what you are talkin' about John. You are going to kill me? For What?"

Capriotti: "Don't you fuckin' lie to me."

Mackey: "John. I don't know what you are talking about. You need to relax."

Capriotti: "Pussy. Liar. Scumbag. You are a shitty person. Let's go outside and fuckin' deal with this."

Mackey stated he became upset and raised his voice.

Mackey: "Outside? You are going to fight me for what? You need to relax. Leave."

Mackey said Capriotti took another step towards Mackey, and poked him in the chest again, harder than the first poke.

Capriotti: "You brought my name up in a meeting. That's the last time you're gonna say my fuckin'

name."

Mackey: "I don't know what you are talking about. When did I say your name?"

Capriotti: "Let's go outside."

Mackey stated Capriotti made some statements eluding to Mackey being involved in the doping scandal that was reported just before the championships began. Mackey said this made him angry. Mackey stated he started to yell at Capriotti. He advised the yelling match lasted for a couple minutes, and both Capriotti and Mackey were yelling back and forth, re-visiting the short conversation detailed above. Mackey stated, at this time, a group started to form around the two.

Mackey said Starks stepped back away from Mackey, and then stepped between Mackey and Capriotti and said to Capriotti, "We gotta get outta here."

Capriotti: "I know what you fuckin' did. This isn't over. You are fuckin' done."

Mackey advised that Starks escorted Capriotti out of the tents and back to the main track meet. Mackey stated he did not have any further communication with Capriotti after this incident.

Mackey again insisted that he did not want to pursue criminal charges, and only requested I take an informational report pertaining to the incident.
